- 4. Financial: ACTION

 - c) Agriculture liability This is set aside for clearing land, for the ALR (behind Froese, logged by Marty & Bo 992-12)
 - d) Accrual spelling is correct
 - e) Reviewing Budget at Ops Meeting August 29, 2018 4:00p.m. completed email for approval
- 5. Field Brushing (Planting, Surveying, Brushing, etc.): FSP lack of broad referral resulted in loss summer days for planning or building.
 - a) **Logging** CHC at Block 51 Mtnview logging, McLennan/Braaten at Block 50 Mtn View road building
 - b) **Brushing** contine to run into heavy blocks but stocking is good, worth being in, when done will know complete hectares & cost. Should have been done 4-5 years ago. Thinning in cedar & spacing, machine press stems, some deciduous (Bi) spacing as commercial species, maybe even some Aspen. More cost as waited too long. Planting was very well, now brushing done well. Basis AAC create/maintain good jobs Integrity Contracting. 3-5 years should be caught up on Silviculture activities, VCF accrual rate is less, as our stands are different, their financial situation different.
 - c) **Grant/Lidar** Lidar, ours is done (no smoke), data in Dec, TSA Feb (if no NDIT grant, 68,000 our 1st attempt realized that obligation of land based tenure holder, it needs to be "special")

- d) Waste and Residue all but 23 (60% done last year) / 3,808m3 budget 17,000, cost 11,300. 4 sm blocks next year recommend to do different, large volumes on Belle/Mac less in 23. Under 3 or 4ft considered bucking waste, 10" under has to be solid for S/L makes GR 4 but not big enough for P & R. Why mill specs don't meet species standard. Vendor vs own tenure, Licensee. Carrier chopped up P & R and take fine, their stumpage is \$28.00 us 3.25. BKB lots of S/L left, in contract should make him be responsible for, approx. 4 loads goes against cut, CP 29 a lot standing/31 his specs different (full log). Give admin fee, how much S/L more preinventory, on 31 note faults. Look at Blk for next summer, but has to finish others first. No penalty in contracts for slash, performance based dictates next work or lack there of, monitor daily
- e) **Road Maintenance** roads opened for next years work, Macintosh culverts, ditching and widening being done.
- f) Hazard Abatement Ecora produced overlay map with BC Hazard Risk Assessment Map", followed procedures which includes avg slop, rate, aspect all worth so many points the can determine the abatement action. By regs have to do if asked (C&E). Can't burn due to indexes (will have our own weather station which will change this), completed on both piles and blocks. Pacific BioEnergy here next week to determine what will take in Winter 2018 Mac rd to Snowshoe Power Plant lots can't burn too close to powerlines, alternate plan to bury. We get \$4/bone dry or \$2/tonne. Grind piles on site UNBC doing study on Cedar with them all species plus take all off blocks.
