Chair Monroe called the MEETING TO **ORDER** at 4:02pm.

- 1. Introduction of Late Items: none
- 2. Approval of Agenda: Director McLennan, second Director Kuzma

- 4. Management Report: A question put forward by Director Kuzma regarding follow up on the Renshaw is NDIT an option? Director Kuzma indicates that, when he was on the Board at NDIT, there were regional funding allocations. Additionally, is there a master spreadsheet being kept showing cut control by species? ## 6. <u>OLD</u>

A) <u>Limited Partnership</u>: CP to draft taxation and organizational structure as a conversation starter with the Shareholder, and the Board will weigh in prior to it going to the lawyer. We need to offer a governance framework to the Shareholder as soon as possible.

## 7. <u>New Items</u>

- A) <u>FN referrals:</u> CP is working on getting them up here in the coming weeks. They have selected roughly two thirds of the blocks for cultural heritage assessments.
- **B)** <u>Policies to review/approve:</u> take more time and review at a later date. The procurement policy needs more work. CP to come back with recommendations.
- C) <u>Overview Geotech Assessment:</u> Board agrees. Assessments were done up the Morkill by the same company and was beneficial. The budget supports the assessments being done.
- D) <u>Recreation 2024</u>: Rec Sites and Trails BC has committed to dock replacements, site upgrades and the reopening of Little Lasalle. The Teare road is closed until further notice. Signage will be provided. The RS&T crew will be coming around the second week of June for site work. MCFC was unable to secure a maintenance contract before season open, so Rosie Evans will be handling the site maintenance for 2024 as an employee of MCFC.
- E) <u>Daycare letter</u>: changes in the funding approval process. More to come soon.
